GENERAL INFORMATION

DERIVA DRT is a uniquely formulated methylated seed oil-based adjuvant developed to increase pesticide deposition and reduce drift potential of agricultural sprays. DERIVA DRT is fully compatible with a wide variety of spray nozzles including conventional flat fan and air induction nozzles. Spray drift reduction is dependent on a number of factors, including equipment set up and environmental conditions at the time of application. Do not use DERIVA DRT with pesticides that do not permit inclusion of oil-based formulations in the spray mix.

PRECAUTIONARY STATEMENTS

Wash hands, forearms and face thoroughly after handling. Wear protective clothing, eye protection, face protection. If on skin: Wash with plenty of water/... IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Specific treatment (see supplemental first aid instruction on this label). If skin irritation occurs: Get medical advice/attention. If eye irritation persists: Get medical advice/attention. Take off contaminated clothing and wash it before reuse.

DIRECTIONS FOR USE

Read directions and conditions of sale and warranty before purchasing or using this product. Use strictly in accordance with accompanying pesticide label warnings and directions. DERIVA DRT can be used at rates from 4 to 6 ounces per acre. Use 4 oz of DERIVA DRT at spray volumes below 10 gallons per acre and 6 ounces per acre at spray volumes above 20 gallons per acre.

DERIVA DRT is not for aquatic use.

MIXING INSTRUCTIONS

To prepare for pesticide application, fill spray tank 2/3 full with water and begin agitation. Add pesticide or fertilizer as recommended and then add DERIVA DRT while continuing agitation. Continue to agitate until tank is full and agitate before and during each application.

PRINCIPAL FUNCTIONING AGENTS

All ingredients are exempt from tolerance requirements as specified in federal regulation 40 CFR 180.

FIRST AID

SKIN: Wash with soap and water for 10-15 minutes . If irritation persist, get medical attention.

EYES: Flush with cool water for at least 15 minutes. Remove contact lenses if present and easy to do; continue rinsing. If irritation persist, get medical attention.

INGESTION: Drink large amounts of water. DO NOT INDUCE VOMITING. Get medical attention immediately or call a Poison Control Center. Do not give anything by mouth to an unconscious person.

INHALATION: Get person to fresh air. If unconscious get medical attention.

Higher spray pressure or greater agitation requires higher rates to maintain good drift control. If unacceptable drift is still occurring, add additional DERIVA DRT in increments of 1 oz. per 100 cal. of spray solution.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal of this product. Storage: Keep only in original container in a cool well ventilated area. Keep container closed when not in use. Store in a well ventilated place. DO NOT STORE BELOW 40° F. Product will solidify but liquifies upon warming up. Store between 40° F and 100° F.

Disposal: Triple pressure rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. To contact your state and local ACRC recycler visit www.acrecycle.org. Dispose of contents/container in accordance with local/national regulations.
