

Statera Corn Mix 2x2

GENERAL INFORMATION

Statera Corn Mix 2x2 is a blend of macro & micronutrients designed for use in all cropping systems as an additive to row starter fertilizers. Statera Corn Mix 2x2 provides EDTA chelated and readily available mineral nutrition that is in the most plant available forms, for early-season root growth and vigor.

Statera Corn Mix 2x2 is compatible with orthophosphate and polyphosphate starter fertilizers.

Statera Corn Mix 2x2 is intended to be used as an addition to a NPK starter fertilizer. Starter fertilizers should be a supplement to a standard fertility program and alone will not provide all the necessary nutrition to optimize vields.

APPLICATION RECOMMENDATIONS

When mixing Statera Corn Mix 2x2 with any other fertilizers or pesticides, the individual making the mix is responsible for the seed safety of the mix. A jar test should be performed prior to mixing Statera Corn Mix 2x2 with any other fertilizer blend or pesticide. Observe mixture for a 24 hour period, prior to mixing large quantities, to insure compatibility.

Soil Applications

Row Starters - Apply 1 to 4 quarts/acre in-furrow or 2 x 2 at planting depending on soil fertility needs.

TANK MIXING INSTRUCTIONS WITH FERTILIZERS

- 1. Fill tank at least $\frac{1}{2}$ full of liquid fertilizer.
- 2. Add any additional pesticides.
- 3. Fill balance of tank with liquid fertilizer or water.
- 4. Pour in desired rate of Statera Corn Mix 2x2.

Foliar Applications

Broadcast - Apply 1 to 2 quarts/acre as a broadcast application to minimize nutrient deficiencies. Dilute with water and apply in a minimum of 10 gallons /acre.

TANK MIXING INSTRUCTIONS WITH PESTICIDES

- 1. Fill tank 1/2 full of water.
- Add AMS based water conditioner adjuvants and other tank mix adjuvants (as needed), agitate.
- 3. Pour in desired rate of Statera Corn Mix 2x2, continue agitation.
- 4. Add pesticides per label, continue agitation.
- 5. Finish filling tank.

NOTES

All micronutrient blends can potentially cause antagonism when tank mixed with pesticides. Consult tank mix instructions on pesticide label(s) prior to adding Statera Corn Mix 2x2 to tank.

STORAGE & DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Store in clean, polyethylene or stainless steel dedicated tanks. This product will freeze at 32°F. Store above 41°F. Triple rinse containers (or equivalent) prior to disposal. Add rinsate to tank. Offer container for recycling or dispose of properly according to state and local authorities. If burned, stay out of smoke.

PRECAUTIONARY STATEMENTS

Avoid contact with eyes, skin and clothing. Avoid contact with open cuts or sores. Avoid breathing vapors. Use with adequate ventilation. Eye protection and gloves are suggested when handling undiluted product. Wash thoroughly after handling and using this product. Product users should avoid prolonged or repeated skin contact by wearing impervious gloves, long sleeve shirt, long pants, socks and rubber boots. Splash-proof safety goggles for eye protection are recommended.

FIRST AID
